What is the Bank of Sweden Tercentenary Foundation?

The Bank of Sweden Tercentenary Foundation was established by an act of the Swedish Riksdag in April 1962. At the suggestion of Bank of Sweden delegates, 250 million Swedish crowns, in the form of securities from the Bank of Sweden portfolio, were set aside from the Bank's 1961 earnings and allotted to a special tercentenary fund. According to the proposal, the revenue from the bequest was to be used to support and promote scientific research related to Sweden. By means of this bequest, the delegates wished to commemorate the Bank's tricentennial in 1968 while simultaneously supporting activities of urgent national interest. The Bank of Sweden, the oldest central bank in the world, has been owned by and linked to the country's parliament throughout the centuries of its existence.

In conjunction with its decision to make a tricentennial bequest, the Swedish parliament, the Riksdag, appointed a special committee to draw up detailed guidelines and statutes for the Foundation. The Prime Minister was appointed chairman of this committee. Proposals on the Tercentenary Foundation were submitted to the Riksdag in April 1964. These proposals suggested that the activities of the Foundation should initially "concentrate on research aimed at expanding knowledge about the impact of technical, economic and social changes on the society and on individual citizens".

The following is cited as the reason for the Foundation's priorities: "Conditions for the coexistence of peoples have changed radically in the past 50 years. A major cause of these changes has been the successful research creating new or enhanced resources in virtually every aspect of life. By expanding knowledge and insights, this research has contributed to increased prosperity, security and well-being in the society. But efforts to achieve these ends have sometimes had adverse effects on the quality of life in certain respects and threatened to erode essential values. The committee feels that greater attention devoted to the problems associated with the society's and the individual's adaptation to changes arising in this manner is a matter of the utmost urgency."

Statutes for the Bank of Sweden Tercentenary Foundation were approved by the Riksdag in December 1964. These statutes stipulated that the objective of the Foundation is to support and promote scientific research related to Sweden. The Foundation's programme was to be given considerable flexibility, and no field of research was to be excluded, in principle, from the possibility of receiving a grant. However, the Foundation was to give priority to research for which there were generally fewer opportunities for grants. The statutes also prescribed that Foundation funds be used for special support to large, long-range projects. The Foundation was to identify new research fields calling

for rapid and major supportive measures. The Foundation was also to promote contacts with international research activities.

Foundation grants were first awarded in October 1965. By the end of 1982, grants totalling about 400 million Swedish crowns had been awarded, about 50 % of which to research in the field of social science, about 20 % to research in the humanities and the remainder to natural sciences, medicine and technology. Grants have primarily been made to large, long-range projects. The average size of annual grants was about 170 000 Swedish crowns from 1965 to 1982.

In May 1974, and again in May 1978, the Swedish Riksdag decided to appropriate a further 100 million Swedish crowns for the Foundation.

Procedure

The Board of Directors of the Foundation had four formal meetings in 1982. The Chairman of the Board is Professor Staffan Helmfrid. Before applications for grants are formally considered by the Board, they are first reviewed and assessed by committees appointed by the Board. The committees, each dealing mainly with specific fields, include Board members and specially appointed experts. Most applications are reviewed by outside experts as well as by the committees.

Finances

The Foundation's economic position for the years ending 1981 and 1982 is decribed in Tables 1 and 2 (Balance Sheet and Appropriation Account).

In 1982 the Foundation made 228 research grants totalling 41.2 million Swedish crowns. Approx. 900 000 Swedish crowns were expended to cover automatic wage increases, project travel expenses and committee work.

A little more than 33 % of the funds available for grants were awarded to new projects in 1982, as opposed to 27 % in 1981. The grants averaged 181 000 Swedish crowns in 1982 (176 000 in 1981). This represents a large decline in real terms compared to previous years. In 1978, for example, the average grant amounted to 158 000. This would be equivalent to about 216 000 Swedish crowns in 1982 prices.

The Foundation's award capacity is totally dependent on the returns yielded by assets placed at the disposal of the Foundation by decree of the Swedish parliament. The assets consist of a securities portfolio managed by the Bank of Sweden.

From 1968 to 1974, interest revenue amounted to about 20 million Swedish crowns per annum. From 1975 to 1978 annual revenue rose to 27 million crowns, following an additional capital allocation of 100 million Swedish crowns in 1974. From 1979 to 1982, revenue amounted to about 36, 41, 50 and 52 million crowns respectively. The 1979 increase was due to the increased capitalization (100 million) allocated by parliament in 1978. The 1980 and 1981 increases were due to the replacement of certain low-yield securities with higher yield securities. No equivalent increases are anticipated in the next few years. So there has been a nominal increase in the magnitude of Foundation grants in recent years, an increase more or less corresponding to price increases in Sweden. However, increases in research costs have actually been far greater than changes in the consumer price index would suggest. Thus, it has not been possible to sustain the Foundation's award capacity in real terms. Measures to sustain this award capacity in years to come would be highly desirable and are currently the subject of deliberation.

Project Follow-up

Most of the research projects supported by Foundation funds deal with problems of general social pertinence. The dissemination of research results for discussion and critical scrutiny is therefore important.

As a result of its direct links to parliament, the Foundation plays a unique role as an intermediary between politicians and scientists. That is why a number of project presentation meetings were held during the year for members of parliament and other decision-makers.

As in previous years, the Foundation's Board of Directors and members of parliament visited a number of projects in different parts of the country and at universities and colleges. Detailed talks were then held on the design and objectives of financed projects. The general research problems of these schools were also discussed.

The special committees even had numerous contacts with representatives of their respective research fields. The object of these contacts was to stimulate research and development activities in these areas. Three reports were published during the year.

The Foundation also has the task of promoting contact with international research programmes. One example of this activity was a symposium held in Vienna. It presented a number of interdisciplinary projects dealing with cultural indicators. Swedish scientists have also been awarded grants enabling them to present their work at foreign universities and symposia.

The Foundations continuously publishes summaries of research results, reports form symposia and other material (in Swedish only) in a form readily comprehensible to laymen.

Strategy and Market – patterns in the development of Swedish industrial enterprises
