The Tasks of the Bank of Sweden Tercentenary Foundation

According to its statutes, the objective of the Foundation is to support and promote scientific research related to Sweden. This means that a) precedence is given to research fields which are not adequately financed in other ways, b) Foundation grants are primarily made to major, long-term projects, c) special support is provided for new research fields demanding rapid and comprehensive measures, and d) contacts with international research activities are promoted.

The guidelines drawn up prior to the Riksdag's adoption of the Foundation statutes prescribed that the activities of the Foundation initially "concentrate on research aimed at expanding knowledge about the impact of technical, economic and social changes on the society and on individual citizens".

The statutes call for considerable flexibility in Foundation programmes. In principle, no field of research is to be excluded from the possibility of receiving a Foundation grant.

Thus, the Board of Directors feels that socially important fields of research which lack any particular representatives should also receive special support. In this manner, Foundation resources can be viewed primarily as a *complement*, not as an alternative, to resources already available for financing research in Sweden.

Procedure

The Board of Directors had four formal meetings during the year. In most cases, applications for grants are vetted by special experts prior to consideration by the Board. Applications are also reviewed and assessed by one or more committees (priority assignment committees) before being ruled on by the Board. The committees consist of Board members and experts outside the Board. At the end of the year, the five committees appointed by the Board were composed of the following members:

The special committees were all chaired by the Foundation's Director. Ms. Nina Lindgren and Ms. Kerstin Stigmark were the *secretaries* of groups 2 and 1 respectively.

Finances

The Foundation's economic position on December 31, 1984 and 1983 is described in tables below.

The item *Bequests* under Liabilities in the BALANCE SHEET consists of two subentries: "Capital" and "Valuation difference, bequest capital." "Capital" consists of securities listed at the book values recorded for them at the time of their transfer to the Foundation (1962, 1974 and 1978). "Valuation difference, bequest capital" constitutes the difference between the face value of the securities portfolio and the previous book value of those securities. This item declined by 1 284 670 Swedish crowns during the year. The result is also listed in the APPROPRIATION ACCOUNT (*Expenses*, Sale and revaluation effects; and *Revenue*, Brought forward from "Valuation difference, bequest capital").

The decline corresponds to the cost incurred when low-yield securities were replaced with high-yield securities. Low-yield securities are then often sold at prices less than the face value. Transactions of this kind are carried out to increase the yield of a securities portfolio. As the APPROPRIATION ACCOUNT Table shows, interest revenue from Foundation securities increased by more than 8.5 million Swedish crowns compared to the preceding year.

The Assets side of the Balance Sheet comprises the Foundation's securities, listed, as before, at the face values. (A footnote also describes the contents and rate on December 31.) This item declined by 890 000 Swedish crowns during the year. The decline was largely due to the fact that some of the bonds were drawn, i.e. fell due for redemption, and to the aforementioned sale and acquisitions.

Project Grants

During the year, the Foundation approved 226 research grants totalling 49.4 million Swedish crowns (Table 3, p. 14) plus 1.3 million Swedish crowns to cover automatic salary increases, travel expenses for ongoing projects and the work of the special committees. Other project costs amounted to 2 million Swedish crowns. Administrative costs (specified below) amounted to 2.1 million Swedish crowns.

A special section (pp. 20-42) describes *new* research projects to which grants were awarded in 1984. It is followed by summaries of all the research projects, listed by subject, hitherto supported by Foundation grants. Certain statistical information is also supplied (pp. 14-17) on the applications considered.

Awarded grants are utilised according to special conditions specified in the contract with every grant recipient and according to the rules drawn up by the Foundation for grant recipients and grant administrators. Virtually every grant awarded by the Foundation is administered by some state-run school which then serves as the employer of the staff being paid with grant funds. The administration fee (4.3 million Swedish crowns) paid to schools in 1984 is listed in specifications for project costs (B 2).

18 % of the grant funds awarded in 1984 went to new projects. The corresponding percentages for the three preceding years were 28 %, 33 % and 27 % respectively. Only 10 % of the new grants sought were ultimately approved. The 1983 figure was 16 %. So competition for funds to finance new projects is very keen. The average size of grants has retained about the same value in real terms over the past five years. The average grant in 1980, 160 000 Swedish crowns, would have been equivalent to 228 000 Swedish crowns in 1984 if incremented to reflect changes in the consumer price index. The average size of grants in 1984 was 219 000 Swedish crowns.

Assets

The Foundation's grant capacity is totally dependent on the yield from assets placed at the disposal of the Foundation by decree of the Swedish parliament. The assets consist of a securities portfolio (bonds) managed by the Bank of Sweden. The Foundation's cash assets also generate some interest revenue.

From 1968 to 1974, revenue amounted to 20 million Swedish crowns per annum. From 1975 to 1978, annual revenue rose to 27 million Swedish crowns, following an additional Riksdag appropriation of 100 million Swedish crowns in the spring of 1974. In 1979 and 1980 annual revenue amounted to 36 and 41 million Swedish crowns respectively. It rose to more than 50 million Swedish crowns a year from 1981 (amounting to more than 60 million Swedish crowns last year). The 1979 increase was due to the increased capitalization (100 million Swedish crowns) granted by the Riksdagen in 1978. Subsequent increases were due to the redemption or sale of certain low-yield securities. Securities with a higher yield could then be purchased. Revenue increases of the latter kind are expected to be completely marginal in the next few years.

So there has been a *nominal* increase in the magnitude of Foundation grants in recent years. After 1978, the average annual increase exceeded the general consumer price index in Sweden. However, the Board ruled to increment the annual budget only by amounts related to general price increases, despite real increases in research project costs which greatly outpaced consumer price index increases. This has resulted in the allocation of some research funds for future years. On the other hand, the Foundation's award capacity could not be sustained in *real* terms. (If the end of the 1960's is used as the base year, the decline in award capacity would be found to be very considerable.)

Project Follow-up

Many of the research projects supported by Foundation funds deal with problems of general social pertinence. The dissemination of research results for discussion and critical scrutiny is therefore important. That is why e.g. a number of meetings were held during the year at which certain projects were presented and discussed.

The 1983 Annual Report mentioned a symposium called VADAN OCH VARTHÄN? FRÅGOR OM SVERIGE OCH DESS FRAMTID (Eng. = Where do we go from here? Sweden and its future), held in collaboration with the Swedish Council for Research in the Humanities and Social Science and the Industrial Council for Social and Economic Studies. As part of the preparations for this symposium, the Foundation held a multidisciplinary seminar on one of the symposium subjects, viz. FAMILJEN (Eng. = The family). This seminar, led by Prof. Bengt-Erik Andersson, resulted in a book: "FAMILJEBILDER: Myter, verklighet, visioner" (Eng. = Family pictures: myths, reality, visions) containing 14 essays contributed by scientists from various disciplines.

This book served as the starting point for a discussion held in the Riksdag's building in the beginning of March. Members of social, cultural and educational parliamentary select committees participated, as well as representatives of the relevant ministries and agencies. A number of authors and scientists in the field also took part. Five members of parliament (each representing one of the five parties in the Riksdag) launched the discussion. The subjects to which particular attention was devoted were the politically interesting aspects of the research reports and the problems described therein with which politicians could begin working.

The question of FORSKNINGENS DATABEHOV OCH DATAHANTERING OCH KRAVET PÅ PERSONINTEGRITET (Eng. = Data requirements in research, data handling and the preservation of personal privacy) has been raised from time to time in projects supported by the Foundation, especially in social science and medical research. Data on individuals over a long period of time are essential to any meaningful expansion of the corpus of knowledge in many fields. The handling of these data is a delicate issue. Scientists have reported increasing difficulty in gathering data. The difficulties are probably related to the public debate on society's need for statistical information and the protection of citizens against invasion of privacy.

In the middle of March, a discussion was held in the Riksdag's building on this subject with the participation of the Standing Committee on the Constitution. Representatives of the relevant ministries and agencies took part, in addition to members of the Standing Committee and scientists.

In accordance with its statutes, the Foundation also has the task of promoting contacts with international research programmes. Thus, special travel grants were awarded to enable a number of scientists to present projects and research results at foreign universities or at scientific symposia. There is also a wide-ranging exchange of information with foreign foundations, especially in Europe, with programmes similar to the Tercentenary Foundation's. This kind of information exchange

frequently leads to the establishment of invaluable contacts between individual scientists or groups of scientists.

In the middle of September, a symposium on the subject "Foundations and Public Relations" was held in Stockholm in conjunction with a meeting between representatives of a number of foundations. Many of the Board's members took part in this symposium. The "Relations to Policy Makers" session was the source of particular interest. The participation by members of parliament in the work of a foundation or research council in the same direct manner as in the Tercentenary Foundation is very uncommon in most countries.

As before, the Foundation's Board of Directors and/or committees have carried out a number of project visits to various universities and colleges. Detailed discussions were held on project objectives and design. Discussions were also held on general problems of research at universities etc.

Under the heading "Universiteten som forskningsmiljö" (Eng. = Universities as a research environment), a discussion was held in the middle of October between members of the educational select committee, the Board of Directors, members of the Foundation's standing committees and scientists. The discussion was held at Stockholm University. Special attention was devoted to the humanities, behavioural science and social sciences.

The special committees had numerous contacts with representatives for the various disciplines in their field. The object of these contacts was to encourage research and development work in the respective fields. Two reports were published during the year: ALKOHOLPOLITIKEN OCH FORSKNINGEN (RJ 1984:1) (Eng. = Alcohol policy and research) and ÖSTSTATSFORSKNING I SVERIGE 1950-1983, Forskningsöversikt och bibliografi (RJ 1984:2) (Eng. = Eastern bloc research in Sweden; research review and bibliography).

The activities described above are steps in the Foundation's dissemination of information on programmes it supports. But they should also be seen as a way for the Board, experts and Foundation staff to keep up-to-date on research results, points of departure, conditions etc. in projects supported by Foundation grants as the basis for improved assessment of measures undertaken with available research funds. Meetings at which members of parliament and scientists can join together for a mutual exchange of information are of particular merit. Thanks to its unique links to the Riksdag, the Foundation can serve as a liason between politicians and scientists.

The Bank of Sweden's accounting department audits Foundation accounts throughout the year. An audit was also carried out by the representatives of the Riksdag's accounting office. In accordance with its statutes, the Foundation will submit its Annual Report to the Riksdag's accountants.
